As you are aware that the inspection of your institution was conducted on 04.10.2021 by the inspection team constituted by Haryana State Council for Physiotherapy for the purpose of grant of recognition of the courses mentioned in the subject. The main deficiencies pointed out by the inspection team are as under:

1. Infrastructure:

- i) Functional diagnostic lab are not established.
- ii) Equipment's in Exercise Tolerance and Fitness lab, Biomechanics and Kinesiology, Medical physics and fundamental of electrotherapy lab, Electro Therapy and Exercise Therapy were found deficient
- iii) There is no Separate Laboratories for M.P.T. specialization.
- iv) Anatomy and Physiology labs were found deficient.

2. Faculty:

- i) Shortage of faculty i.e. 02 Professor, 03 Associate Professors, 03 Demonstrators, 06 Jr. Physiotherapist.
- ii) List of Guide for Ph.D. candidates is yet to be provided (According to UGC Guidelines).

3. Hospital:

- i) Details of empaneled hospital required to be submitted as per requisite Performa.

On the basis of inspection report, your institution is hereby granted provisional recognition for academic session 2021-22, subject to the condition that the institute will remove all the deficiencies before the commencement of next academic session and the compliance report shall be submitted to the Council office up to 31.03.2022. You are requested to apply to Council after removing all deficiencies for recognition for next academic session 2022-23. Further, for intake of seats, the university is requested to apply for fresh NOC from Department of Medical Education and Research for the purpose of admission in academic session 2021-22.
