Admission process will be conducted on July 17, 2021 (Saturday) 09:30 am and the admission process shall consist of:

- A. Entrance Test
- B. Presentation on the proposed research before the Departmental Research Committee (DRC)
- C. Interview

A. Reporting & Registration 09.30 am to 10.15 am

B. Entrance Test 10.30 am to 12.00 noon

C. Presentation to DRC 14:00 pm onwards

D. Interview 15.00 pm onwards

3 Category of Scholars

Scholars can be registered on full time or on part time basis

- A. A full time scholar has to attend the University regularly and will be subject to the prescribed attendance rules of the University.
- B. Professionally employed personnel may be allowed to pursue PhD on part time basis. Such candidates are required to submit a "No Objection Certificate" from their parent organization/department/employer stating that he/she is permitted to pursue studies on a part-time basis and that his/her duties permit him/her to devote sufficient time for research. Part time scholars will have to attend the classes for assigned coursework as per the rules of the University/UGC.

4 Candidates are required to bring the original and attested copies of the following documents.

- Photo ID Card (Issued by Government Agency)
- 10th 12th Mark sheets & Certificates
- Graduation Mark sheets & Degree / Provisional Certificate
- Post Graduation Mark sheets & Degree / Provisional Certificate
- Four copies of recent passport size photographs
- Any other document supporting prior research work undertaken, if any.

5 Minimum Qualifications for Admission

- A. The minimum qualification required for admission to a PhD Programme is a Master's Degree in the relevant field with a minimum of 55% marks or equivalent grade. Relaxation of 5% of marks from 55% to 50% maybe allowed to SC/ST/OBC/differently abled candidates.
- B. An Equivalence Committee will be constituted by the President of GDGU to consider applications other than covered under section (a) who may propose other qualifications/requirements in specific areas, consistent with the norms of the statutory bodies, to the University Research & Innovation Council (URIC) for its recommendation to the Academic Council for approval.
- C. If considered necessary, DRC may propose other qualifications/requirements in specific areas, consistent with the norms of the statutory bodies, to the URIC for its recommendation to the Academic Council for approval.

6 Eligibility Conditions for Admission

- A. It is desirable that eligible applicant who possess minimum prescribed qualifications for admission to the PhD Programme, have excellent academic/professional track record in the relevant discipline.
- B. The applicant for part-time PhD should:
 - I. prove to the satisfaction of DRC that his/her official duties permit him/her to devote sufficient time to research.

II. ensure that facilities for pursuing research are available at his/her place of work in the chosen field of research, where required.

7 Time Period requirement for Submission of the PhD thesis

A. Minimum Time Period:

The minimum period for submission of PhD thesis is 3 years from the date of registration.

B. Maximum Period:

The maximum period for submission of PhD thesis is 6 years from the date of registration. Thereafter, the registration shall stand cancelled automatically unless, for valid reasons, the President of GDGU grants an extension.

Split- Site PhD- Scholars will have the opportunity to spend equivalent of up to one year at the campus of a partner foreign University. This offers a unique opportunity for collaborative research projects. The selection of candidates will depend on fulfilling of partner institution's eligibility criteria.

Full Time PhD scholars who have successfully completed their course work and demonstrate good progress in their research work would be eligible to apply for Teaching or Research Assistantships. On completing their PhD, DTFs will be considered for Postdoctoral Fellowships.
