

## **2. ABOUT THE CONFERENCE**

Geographical Indications (GIs) occupy a critical intersection between intellectual property law, international trade, cultural heritage, development economics, and increasingly, technology-driven governance systems. Recognized under the TRIPS Agreement and embedded within national and regional legal frameworks, GI protection is widely promoted as a mechanism for safeguarding traditional knowledge, enhancing market differentiation, and supporting rural and artisanal livelihoods. Across jurisdictions—including the European Union, South Asia, and other emerging Global South economies—GI regimes have expanded rapidly, both in scope and regulatory sophistication.

Parallel to this legal expansion, technological interventions—such as digital traceability systems, blockchain-based provenance tools, e-commerce platforms, certification technologies, and data-driven supply chain management—are increasingly being proposed as solutions to long-standing challenges in GI governance, enforcement, and market access. Governments, international organizations, and private actors are investing in technological infrastructures to address issues of misappropriation, counterfeit goods, information asymmetry, and weak enforcement mechanisms.

Despite these developments, there remains limited empirical clarity on whether and how law, economics, and technology together translate into tangible economic gains and measurable social outcomes for primary producers. Existing scholarship has made important doctrinal, policy, and technical contributions; however, comparatively less attention has been paid to field-based evidence, distributional effects within GI value chains, the real-world adoption of technological tools, and their impact on producer agency and livelihoods. This has resulted in a persistent gap between legal intent, technological promise, and lived experience, particularly in contexts characterized by informal production systems, intermediary dominance, and asymmetric bargaining power. Against this backdrop, the proposed International Conference seeks to create a focused, high-level scholarly forum to critically examine the functioning of Geographical Indications in practice by integrating legal analysis, economic evaluation, and technological assessment, drawing on comparative perspectives and empirically grounded research to reassess prevailing assumptions about GI effectiveness.

## 10. ABSTRACT SUBMISSION INSTRUCTIONS

### 10.1 Core of Abstract

- 10.1.1 Title and Authors' Details: The abstract must include a clear and concise title (maximum 15 words), along with the author details, including the full names of all authors, their institutional affiliations, and email addresses, with the presenting author clearly marked with an asterisk (\*).
- 10.1.2 Word Limit: The word limit for the abstract shall be 400-600 words.
- 10.1.3 Research Gap: Briefly identify the research gap in 1–2 sentences.
- 10.1.4 Objectives: Clearly state the aims or objectives of the study in 1–2 sentences.
- 10.1.5 Methodology: Indicate the research methodology used (e.g., doctrinal analysis, case studies, comparative analysis, empirical research).
- 10.1.6 Key findings or expected outcomes: Highlight the major findings or expected results of the research.
- 10.1.7 Originality: Explain how the research contributes to interdisciplinary scholarship or advances existing discourse.

10.2 Formatting Rules: Authors must adhere to the following formatting requirements.

10.2.1 Font: Times New Roman, 12 pt.

10.2.2 Spacing: 1.5 Spacing

10.2.3 Alignment- Justified

10.2.4 File type: .docx or .pdf

10.2.5 File name format: LastName\_Topic.docx

10.3 Submission Process: Abstracts must be submitted through the online conference submission portal. **Submission link:** <https://forms.gle/Pb5iLPMhcTx8oPiw7>

10.4 Ethical Guidelines: Original work is required, with plagiarism and AI checks ensuring no more than 10% similarity. **Only one abstract is allowed per presenter, and each paper can have a maximum of three authors.**

## 11. CASE STUDY FORMAT FOR SUBMISSION

The case studies must be submitted through the **same registration link**. The indicators mentioned below serve as guiding parameters and participants are encouraged to incorporate relevant indicators while preparing their case studies. These guidelines constitute an integral part of the indicative rubrics for case study submission.

### 11.1 Relevance to Geographical Indications (15%)

11.1.1 Clear identification of a GI product or GI-related issue. Consideration of the participation, rights, and representation of artisans, farmers, and local producer communities involved in the GI product.

11.1.2 Demonstrates linkage between the product and its geographical origin (quality, reputation, or characteristics, originally clicked pictures may be used).

### 11.2 Contextual and Historical Background (10%)

11.2.1 Provides a concise overview of the product's origin, traditional practices, and socio-cultural significance.

11.2.2 Explains the evolution of the GI and its importance to the region or community towards sustainability.

### 11.3 Legal and Institutional Analysis (15%)

11.3.1 Examination of the legal framework governing the GI (national and/or international).

11.3.2 Discussion of institutions dealing with producer groups, government bodies, international organizations.

#### **11.4 Methodology and Evidence (10%)**

- 11.4.1 Use of credible sources, fieldwork, data, or empirical evidence (inclusive of pictures and videos).
- 11.4.2 Clear explanation of the research or analytical approach used.

#### **11.5 Economic and Social Impact (10%)**

- 11.5.1 Assessment of how GI protection affects producers, local communities, markets, or rural development.
- 11.5.2 Evaluation of Gender Roles and Livelihood

#### **11.6 Environmental and Cultural Sustainability (10%)**

- 11.6.1 Consideration of biodiversity, traditional knowledge, and sustainability of production practices.
- 11.6.2 Entrepreneurship, Generational Skills, and demand of Novation.

#### **11.7 Challenges and Governance Issues (15%)**

## **12. AUTHOR GUIDELINES FOR PAPER PUBLICATIONS**

- 12.1 The authors who are interested in the paper publication shall follow the Author's Guidelines. The last date to submit papers is 30 April 2026, Thursday. Separate submission guidelines will be shared after the conference.

- 
- 12.2 All submissions must be written in English.
- 12.3 The full paper should be between 3000–6000 words, including references and footnotes.
- 12.4 All citations and references must conform to the Bluebook: A Uniform System of Citation (21st edition).
- 12.5 Only original and unpublished work will be considered. Submitted papers must not be under review or previously published elsewhere. All papers will undergo plagiarism and AI-content checks, and submissions exceeding 10% similarity or AI-generated content may be rejected.
- 12.6 Review and evaluation criteria: All submitted papers will undergo a peer review process and will be evaluated based on the following criteria:
- 12.6.1 Thematic relevance: The paper should demonstrate a clear and direct connection with the conference themes or sub-themes.
  - 12.6.2 Theoretical contribution: Submissions should contribute to advancing existing scholarship within the fields of law, economics, technology, gender studies and social sciences.
  - 12.6.3 Methodology: The research design and methodology should be appropriate and clearly articulated. Papers may employ doctrinal analysis, empirical research, case studies, comparative analysis, or other relevant methods.
  - 12.6.4 Empirical or doctrinal strength: Papers should demonstrate strong legal reasoning through analysis of statutes, judicial precedents, and legal doctrines, or present reliable empirical data and analysis where applicable.
  - 12.6.5 Policy implications: Submissions should provide clear insights and recommendations relevant to policymakers, technology developers, regulatory bodies, or civil society organizations.
  - 12.6.6 Clarity and Structure: Papers must be well organized, logically structured, and written in accordance with accepted academic writing standards.
  - 12.6.7 Research approach and interdisciplinary engagement: Researchers are encouraged to follow pluralistic and interdisciplinary research approaches.
